Announcement pursuant to sec. 93 Austrian Stock Exchange Act in connection with sec. 91 art. 2 Austrian Stock Exchange Act -Changes of significant shareholdings

Erste Group Bank AG informs the public pursuant to sec. 93 Austrian Stock Exchange Act in connection with sec. 91 art. 1 Austrian Stock Exchange Act that BlackRock, Inc., Wilmington, United States of America, as of 14 October 2016 held 16,812,097 or 3.91% of voting rights attached to shares (previously 3.78%) and 623,718 or 0.15% of voting rights through financial instruments (previously 0.10%) in Erste Group Bank AG (rounded stake in share capital of 4.06% compared to previously 3.88%), thus combined more than 4% of Erste Group Bank AG's share capital (EUR 859,600,000 divided into 429,800,000 voting no-par value bearer shares – ordinary shares).
