Announcement pursuant to sec. 93 Austrian Stock Exchange Act in connection with sec. 91 art. 2 Austrian Stock Exchange Act -Changes of significant shareholdings

Erste Group Bank AG informs the public pursuant to sec. 93 Austrian Stock Exchange Act in connection with sec. 91 art. 1 Austrian Stock Exchange Act that BlackRock, Inc., Wilmington, United States of America, as of <u>15 September 2016</u> held 16,660,459 or 3.88% of voting rights attached to shares (previously 3.83%) and 1,040,544 or 0.24% of voting rights through financial instruments (previously 0.13%) in Erste Group Bank AG (rounded stake in share capital of 4.12% compared to previously 3.95%), thus combined more than 4% of Erste Group Bank AG's share capital (EUR 859,600,000 divided into 429,800,000 voting no-par value bearer shares – ordinary shares).
