Erste Group Bank AG informs the public pursuant to sec. 135 para. 2 Austrian Stock Exchange Act in connection with sec. 134 para. 1 Austrian Stock Exchange Act that BlackRock, Inc., Wilmington, United States of America, as of 10 April 2018 held 21,444,127 or 4.99% of voting rights attached to shares (previously 5.08%) and 296,508 or 0.07% of voting rights through financial instruments (previously 0.11%) in Erste Group Bank AG (rounded stake in share capital of 5.06% compared to previously 5.19%), thus combined more than 5% of Erste Group Bank AG's share capital (EUR 859,600,000 divided into 429,800,000 voting no-par value bearer shares – ordinary shares).
