## Announcement pursuant to sec. 135 para. 2 Austrian Stock Exchange Act in connection with sec. 134 para. 1 Austrian Stock **Exchange Act – Changes of significant shareholdings**

Erste Group Bank AG informs the public pursuant to sec. 135 para. 2 Austrian Stock Exchange Act in connection with sec. 134 para. 1 Austrian Stock Exchange Act that BlackRock, Inc., Wilmington, United States of America, as of 11 April 2018 held 21,119,109 or 4.91% of voting rights attached to shares (previously 4.99%) and 299,518 or 0.07% of voting rights through financial instruments (previously 0.07%) in Erste Group Bank AG (rounded stake in share capital of 4.98% compared to previously 5.06%), thus combined less than 5% of Erste Group Bank AG's share capital (EUR 859,600,000 divided into 429,800,000 voting no-par value bearer shares - ordinary shares).
