Erste Group Bank AG informs the public pursuant to sec. 135 para. 2 Austrian Stock Exchange Act in connection with sec. 134 para. 1 Austrian Stock Exchange Act that BlackRock, Inc., Wilmington, United States of America, as of 19 June 2018 held 17,163,836 or 3.99% of voting rights attached to shares (previously 4.08%) and 2,126,306 or 0.49% of voting rights through financial instruments (previously 0.33%) in Erste Group Bank AG (rounded stake in share capital of 4.49% compared to previously 4.41%), thus combined more than 4% of Erste Group Bank AG's share capital (EUR 859,600,000 divided into 429,800,000 voting no-par value bearer shares – ordinary shares).
