Erste Group Bank AG informs the public pursuant to sec. 135 para. 2 Austrian Stock Exchange Act in connection with sec. 134 para. 1 Austrian Stock Exchange Act that BlackRock, Inc., Wilmington, United States of America, as of 20 June 2018 held 18,095,434 or 4.21% of voting rights attached to shares (previously 3.99%) and 845,532 or 0.20% of voting rights through financial instruments (previously 0.49%) in Erste Group Bank AG (rounded stake in share capital of 4.41% compared to previously 4.49%), thus combined more than 4% of Erste Group Bank AG's share capital (EUR 859,600,000 divided into 429,800,000 voting no-par value bearer shares – ordinary shares).
