



## Announcement pursuant to sec. 135 para. 2 Austrian Stock Exchange Act in connection with sec. 134 para. 1 Austrian Stock Exchange Act – Changes of significant shareholdings

Erste Group Bank AG informs the public pursuant to sec. 135 para. 2 Austrian Stock Exchange Act in connection with sec. 134 para. 1 Austrian Stock Exchange Act that BlackRock, Inc., Wilmington, United States of America, as of 5 February 2019 held 16,993,152 or 3.95% of voting rights attached to shares (previously 4.00%) and 355,007 or 0.08% of voting rights through financial instruments (previously 0.15%) in Erste Group Bank AG (rounded stake in share capital of 4.04% compared to previously 4.15%), thus combined more than 4% of Erste Group Bank AG's share capital (EUR 859,600,000 divided into 429,800,000 voting no-par value bearer shares – ordinary shares).
