

## Announcement pursuant to sec. 135 para. 2 Austrian Stock Exchange Act in connection with sec. 134 para. 1 Austrian Stock Exchange Act – Changes of significant shareholdings

Erste Group Bank AG informs the public pursuant to sec. 135 para. 2 Austrian Stock Exchange Act in connection with sec. 134 para. 1 Austrian Stock Exchange Act that BlackRock, Inc., Wilmington, United States of America, as of 28 February 2019 held 17,517,138 or 4.08% of voting rights attached to shares (previously 3.98%) and 60,617 or 0.01% of voting rights through financial instruments (previously 0.01%) in Erste Group Bank AG (rounded stake in share capital of 4.09% compared to previously 3.99%), thus combined more than 4% of Erste Group Bank AG's share capital (EUR 859,600,000 divided into 429,800,000 voting no-par value bearer shares – ordinary shares).
