Information on data protection

in connection with the Annual General Meeting of Erste Group Bank AG

If you attend the Annual General Meeting of Erste Group Bank AG (either as shareholder, as proxy or as guest), your personal data will be processed. Below we provide you with the essential information.

1 Who is responsible for data processing?

3 For what purpose should the personal data be processed and what is the legal basis for this?

General

Your personal data will be processed in order to conduct the Annual General Meeting of Erste Group Bank AG (preparation, implementation, and follow-up). The associated data processing is mandatory according to the Austrian Stock Corporation Act (Art 6 (1) (c) General Data Protection Regulation). In addition, there may be a legitimate interest to process data for the purposes of legal action, law enforcement or fraud prevention.



Video transmission and recording

The Annual General Meeting will be broadcast over the internet via public live stream (video with audio). The legal basis is sec 102 (4) Stock Corporation Act. The live stream can be viewed at: www.erstegroup.com/generalmeeting. It should be noted that those shareholders or proxies, who speak and take the floor, will be seen in large format during the broadcast.

Since this is a "one-way connection", no video or audio data of people who only follow the Annual General Meeting via live stream will be processed.

Questions received by e-mail in advance of the Annual General Meeting or questions submitted by means of a request to speak form or other document during the Annual General Meeting which the shareholders have requested to be read out may be read out together with the names of the respective persons. If reading out of the names is not desired, this must be indicated accordingly in the request to speak form or other document or e-mail.

The recording of the live broadcast will be publicly available until Monday, 15 May 2023, 04:00 pm via the links provided. This serves the legitimate interest of Erste Group Bank AG to make the results and occurrences of the Annual General Meeting accessible also to those who were unable to attend (or unable to follow the live video broadcast) and, at the same time, giving them the opportunity to view the several-hour recording on the three following days.

4 What data is processed for the purpose indicated above?

For the purposes of handling the Annual General Meeting, master data of the shareholders and authorized representatives, data on representation and data on securities investment is required, i.e. name (company), place of residence (registered office), date of birth (register and registration number of legal entities), amount or number of shares represented, securities account number, voting card number, attendance status, as well as questions asked by email and the answers thereto are processed.

5 Who are the recipients of the personal data?

 Processors and service providers handling the Annual General Meeting, HV Veranstaltungsservice GmbH (Köppel 60, 8242 St. Lorenzen/Wechsel), the notary's office appointed by Erste Group Bank AG and – for video broadcasting and recording – Fa. Martin Seiter (3DHD).



- Public authorities, in particular the Company Register (Vienna Commercial Court), or, where applicable, the Financial Market Authority, the Vienna Stock Exchange or Österreichische Kontrollbank.
- The public with regard to video broadcasting and recording.

6 How long will the personal data be stored and what criteria will be used to determine the duration of storage?

- The personal data of the shareholders and authorized representatives is stored for as long as the status of bearer shareholder applies. Beyond this, for as long as statutory storage requirements apply.
- For the video recording, see point 3.

7 What are the rights of data subjects? Is there a right of complaint?

- Applicable <u>rights</u> are the right of access, to rectification, to erasure, to restrict processing, to object, and to data portability.
- The data subject also has the right to lodge a <u>complaint</u> with the Data Protection Authority, Barichgasse 40-42, 1030 Vienna, dsb@dsb.gv.at.

8 Is the provision of personal data a statutory requirement, is there an obligation to provide it, and what are the possible consequences of failure to provide such data?

The provision of personal data is mandatory by law (Stock Corporation Act). It is not possible to attend the Annual General Meeting without providing it.

9 Is the decision-making process automated and does it include any profiling?

No, such data processing does not take place.

10 Is personal data also processed that was not collected from me?

If you did not register for the Annual General Meeting yourself, we will have received your personal data either from a representative authorized by you or from your custodian bank. In these cases, the data in question is your master data (in particular name, address, and date of birth) as well as details of your securities investment (in particular securities account number and number of shares).
