Login and purchase of the green fee online at www.golfcut.cz

Reservations

1. **Once logged in**, choose your course and date.
2. Select your requested tee time and click on **"Order"**. In Step 2 of ordering, you will see the converted price of the Erste Private Banking benefit programme. **If the price is not converted automatically** (possibly due to your membership in other bonus programmes), select it in Step 2 of ordering – see the image.

4. After the payment, you will receive a **confirmation e-mail** and an invoice; then you just come to the course and **identify yourself at the reception desk**, and you can start playing.

* Each client may use just 1 discounted fee per order. This means it is not possible to order two discounted fees with one order (such as for oneself and a partner, or for oneself and friends).

Problems with reservations

1. Having selected my tee time, I see the full price instead of the discounted Erste Private Banking client price..

Set the price at **"GolfCut_Erste - 10 her"** (you can find it in Step 2 of the ordering process between the registration number and the fee). Select it using the roll-down arrow menu.

Terms and conditions of the GolfCut benefit programme dated 1 January 2021

I. Definition of terms

Client is a person with a Erste Private Banking account.

II. Conditions for the provision of the GolfCut benefit programme

1. If the Client is interested in registering or asking a question regarding the benefit programme, the Client shall contact their banker.
2. During the registration, the Client gives their consent to the provision of personal data needed for proper registration at golfcut.cz operated by Resort Media, s.r.o.
3. Discounted green fees under the GolfCut benefit programme are provided to the eligible person (Client) in the May–September season based on the Client's request submitted to golfcut.cz.
4. The Client shall pay all the costs associated with purchasing the green fee after the application of the Erste Private Banking discount in full amount. The payment may be made exclusively using payment cards at golfcut.cz.
5. The Client may use **up to 10 discounted green fees** at selected courses in the specified value during the May–September season. The Client may purchase **1 entry per day** maximum.
6. The service is non-transferable; hence, only the Erste Private Banking clients may use the discounted green fees personally.
7. You can find the instructions for applying the discounted green fees at the Erste Private Banking website.

9. In the event of exiting the Erste Private Banking service, the Client will be excluded from the GolfCut benefit programme. You can still use the standard benefits for the members of golfcut.cz.
