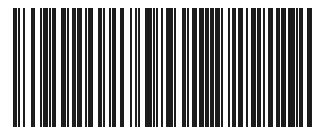

**** **Financial Health Zone** is a free digital service, with which business clients can check their financial rating at Erste Bank at any time, compare their financial situation with the state of competition in their industry, view historical trends in their financial parameters and contact their financial representatives for additional information. The service is provided to business clients of the Small and Medium Clients Sector, and to clients of the Small Entrepreneurship Directorate depending on the fulfillment of certain preconditions.

***** **Financing** enables a partial view of the "Short-term limit" widget within Netbanking. A digital user who has been granted this authorization cannot see accounts, loan or deposit positions, and is not able to perform any functionality other than viewing and submitting requests within the "Short-term limits" widget.
