**SUBJECT: Notification on Prospectus publication method**

Pursuant to the provision of Article 434, Paragraph 4 of the Capital Market Act, and pursuant to Article 9. paragraph 1 and 2 of the Commission Delegated Regulation (EC) No. 2016/301, ERSTE & STEIERMÄRKISCHE BANK d.d., Rijeka, Jadranski trg 3/a, (hereinafter: the „Issuer“) hereby announces the notice on publication method for the public offer bond issue and listing prospectus of ERSTE & STEIERMÄRKISCHE BANK d.d. in the amount of up to HRK 500 million, with fixed interest rate and semi-annual payment of interest, and five-year maturity, on the Official Market of Zagreb Stock Exchange. On 15.11.2018, Croatian Financial Services Supervisory Agency delivered a decision, class: UP/I 976-02/18-01/06, reg. no.: 326-01-60-62-18-14, by which the Issuer is approved the public offer bond issue and listing prospectus (hereinafter: the „Prospectus“).

The subject of the public offer and the admission to Official Market of Zagreb Stock Exchange Inc. is up to HRK 500 million Issuer's bonds, in dematerialised form, registered, in the denomination of HRK 1.000.000,00, at a fixed interest rate with a semi-annual payment of interest, with five-year maturity, identification code: RIBA-O-23BA, ISIN: HRRIBAO23BA6 (hereinafter: the „Bonds“).

The offer period will last for a certain period of time within one working day. Invitation for subscription will be publicly announced one working day before the offer period commences, targeted at 26.11.2018. The Bonds will be admitted to the Official Market of Zagreb Stock Exchange upon receiving the approval by the Zagreb Stock Exchange Inc.
