## Clarifications of terms

The time of receipt of orders is the deadline for receiving payment orders on a working day, orders received after this deadline are considered received on the next working day. The working hours for receiving orders may be shortened before holidays and national holidays, about which Erste banka will inform clients.

The debit date of the client's account is the date on which Erste banka debits the client's account.

The approval date is the approval date of the payee's bank account.

The execution date is the date defined by the client on the payment order for the execution of the payment transaction.

A working day is every day except Saturdays, Sundays, public holidays and holidays in the Republic of Croatia and Catholic Good Friday for transactions in euro currency.

## Other

- <sup>1</sup> The actual approval date of the payee's account depends on the legislation of the payee's country and the rules of the payee's bank.
- <sup>2</sup> Electronic payment orders can be placed in Erste Bank and FINA no earlier than 365 calendar days before the defined date of execution of the payment order.
- <sup>3</sup> Paper payment orders can be submitted in the branches of the Bank and Fina no earlier than 14 calendar days before the defined date of execution of the payment order.
- <sup>4</sup> Clients who are on the list of employers who do not pay contributions must submit orders for salary payments as well as orders for payment of contributions by 2 p.m. so that the order execution date is the current day. If such orders are placed after 2 p.m., the execution date will be the next working day.
- <sup>5</sup> For the purchase and sale of foreign currency in the amount of more than EUR 10,000, clients can agree on a preferential exchange rate on weekdays from 8 a.m. to 4 p.m. The preferential course can be used on weekdays no later than 4:30 p.m.

Revocation of payment order and notice of rejection of payment order is carried out in accordance with the General Terms and Conditions for maintaining transaction accounts and providing payment services for business entities.
