We would like to inform you about changes to the Decision on Fees for Payment Services for legal entities, effective as of August 1st, 2026. You can download the document at this [LINK](#).

Preferential tariffs have already been introduced for FIT 4.0 – international transfers within the Erste and Steiermärkische Sparkasse Group. [FIT 4.0](#) enables companies and individuals to make international transfers more easily, quickly, and cost-efficiently within a single integrated framework comprising 31 banks across 11 countries: Austria, Bosnia and Herzegovina, Croatia, Czech Republic, Hungary, Montenegro, North Macedonia, Romania, Serbia, Slovakia and Slovenia. Incoming transfers through FIT 4.0 are free of charge. As of August 1st, 2026, revised fees will apply for transaction account maintenance and Erste Info service.
