RESOLUTION No. 1/25.04.2018 adopted by the Extraordinary General Meeting of Shareholders of Banca Comerciala Romana SA during the meeting held on 25.04.2018

The Extraordinary General Meeting of Shareholders of BCR SA (BCR SA), convened on 25.04.2018, at 13.00, according to the provisions of art. 111, 113 letter I) and 117 of Law no. 31/1990, republished, amended and completed, and of art. 8, 11.3 letter. g), letter m) and art. 12.1 of BCR SA Charter, at the Bucharest headquarters, no. 15, Calea Victoriei, Sector 3,

being legally convened in the presence of shareholders representing 99,8765% of BCR SA share capital, which secures the validity of the debates, according to art. 115 of Law no. 31/1990, republished, amended and completed and of art. 15.1 letter c) of BCR SA Charter,

approves, with the vote "in favour" expressed by the shareholders representing 99,8780 % of the share capital, according to the votes counting minutes, the extension BCR Debt Issuance Programme validity with an additional 10 years, while keeping the ceiling at 3bn EUR and introduction of new bond structures that can be issued out of the Issuance Programme and also empower the Management Board to decide with regard to each annual update of the Programme, while the final terms and conditions of each bond issue depending on market conditions to be based on BCR's Charter and applicable internal regulation.
