

## **Potential Senior Non Preferred Bond Issue (the “Bonds”) for BCR**

Banca Comerciala Romana S.A. (rated BBB+ by Fitch and Baa1 by Moody's) has mandated BCR and Erste Group as Joint Lead Managers to arrange a series of Fixed Income investor calls commencing on 15 November 2023. A RON denominated Senior Non Preferred Eligible MREL Notes transaction with an intermediate callable maturity will follow, subject to market conditions. The issue is expected to be rated by Fitch and Moody's.

The bond offering will be issued under the Banca Comerciala Romana's Multi Issuer Programme and it will be governed by Romanian law.

The bonds are intended to be:

- offered and sold to investors who are “qualified investors” pursuant to Article 2(e) of Regulation (EU) 2017/1129 of the European Parliament and of the Council of 14 June 2017 on the prospectus to be published when securities are offered to the public or admitted to trading on a regulated market, and repealing Directive 2003/71/EC.
- listed on the Regulated Market administered by the Bucharest Stock Exchange.
