Statement of Politically Exposed Person - 1 copy, original

Izvod iz zemlje domicila - original overen apostilom ili fotokopija overena kod notara zemlje izdavaoca i apostilom dokumenta kao i original prevod na srpski jezik kod sudskog tumača - ne stariji od 3 meseca
Excerpt from registry of the domicil country for each foreign legal entity included in the Statement - original certified with apostille or copy certified by notary from issuer's country and document apostille not older than 3 months. Translated into the Serbian language by court interpreter

Izvod iz nadležnog registra osnivača pravnih lica:

Strana pravna lica - original ili fotokopija overena kod notara zemlje izdavaoca i apostilom dokumenta kao i original prevod na srpski jezik kod sudskog tumača ne stariji od 6 meseci
Excerpt from registry of the domicil country - foreign legal entity original or copy certified by notary from issuer's country and apostille of document and translation into the Serbian language by court interpreter

Akt/Odluka o imenovanju predsednika/zastupnika - original overen apostilom I fotokopija overena kod notara zemlje izdavaoca i apostilom dokumenta - overa dokumenta ne sme biti starija od 3 meseca

Act on appointing the person authorised for representation - original certified with apostille and copy certified by notary from issuer's country and with apostille, not older than 3 months

(**Napomena:** prilikom pribavljanja dokumentacije o osnivačima, overu treba proveriti prema „Instrukciji za postupanje i proveru dokumenata izdatih u inostranstvu“ koja se nalazi na Portalu Banke).

(**Notice:** During acquiring owner's documentation, certification needs to be checked according to the "Instruction for handling and verification of documents issued abroad", which is located on the Bank's Portal).

Potvrda o licima koja su ovlašćeni potpisnici - original overen apostilom ili fotokopija overena kod notara zemlje izdavaoca i apostilom dokumenta, kao i original prevoda na srpski jezik kod sudskog tumača - ne stariji od 3 meseca

Certificate of persons "Authorised signatories", original certified with apostille or copy certified by notary from issuer's country and with apostille of document. Translation into the Serbian language certified by court interpreter - not older than 3 months

(**Napomena:** Potvrdu o licima koji su ovlašćeni potpisnici dostaviti zajedno sa uzorkom potpisa svakog tog lica uz ime tog lica koje je na listi ili ovlašćenju). Uzorak potpisa nije neophodan ukoliko klijent lično svu dokumentaciju potpisuje pred radnikom Banke.

(**Notice:** Confirmation of the persons who are authorized signatories, submitted along with a sample signature of each such person with the name of the person who is on the list of the authority). Signature sample is not required if client signs documentation in front of bank officer.

ID or passport - authorized person, person from specimen of signatures and user of - copy and original presented

Contract for the opening and maintaining of dinar/foreign currency payment account - 2 copies, original

Karton deponovanih potpisa KOMBINOVANI za dinarski i za devizni platni račun (obrazac Banke) - 2 primerka, original
Specimen of signatures for dinar/foreign currency payment account - 2 copies, original

OP obrazac punomoćnika - 1 primerak, original overen apostilom ili fotokopija overena kod notara i apostilom dokumenta - ne stariji od 3 meseca. OP nije neophodan ukoliko klijent svu dokumentaciju potpisuje pred radnikom Banke

Authorised signatures on particular form (OP form) - 1 copy, original certified with apostille or copy certified by notary and document apostille, not older than 3 months. Signature sample is not required if client signs documentation in front of bank officer
