\*\*\* In cases when the loan purpose is the purchase of a real estate, early loan repayment fee can be charged in accordance with the Law on the Protection of Financial Service Consumers, Article 36:

Early loan repayment fee can be charged only if the amount of early loan repayment for 12 months is higher than RSD 1,000,000. Early loan repayment fee amounts 1%, and if the period between the early loan repayment and the end of loan repayment is shorter than a year, the fee can be maximum 0.5%.

Early loan repayment fee cannot be higher than the amount of suffered damage, which is the difference between contractual interest rate and market interest rate under which early repaid funds can be disbursed.

The fee cannot be higher than the amount of interest the borrower could pay for the particular period in any case.

In cases when the purpose of loan is not purchase of real estate, early loan repayment fee cannot be charged.

\*\*\*\* In case of loan from the guarantee scheme, the rule of minimum amount of RSD 3,000 is not applied, management fee is charged in the amount of 0.20%.

\*\*\*\*\* Clients are obliged:

a) Not to pay share in profit (dividends) or return of founder's borrowing in the first year after entering into the Agreement;

b) Not to execute early loan repayment from existing loans with the same intention at any other Bank.

\*\*\*\*\* Fee for non-settlement of conditions on payment transactions is charged up to maximum 1.00% of the amount of loan for the entire period of loan repayment.
