Charges and expenses connected with Active portfolio management

The example of charges and expenses is calculated annually. It is based on the position of portfolios as at 31/12/2018 and the level of published ongoing expenses in the individual portfolio funds as at 31/12/2018. Private bankers will provide a detailed breakdown of charges and expenses for clients.

No change is planned in the portfolio management fee.

The real ongoing and transaction expenses will vary depending on the current portfolio positions and the frequency of trading in third party funds. When purchasing or selling units, Erste Group AG charges a fee of 0.05% of the transaction volume, with a minimum level of EUR 6.90.

Absolute values are based on an investment of EUR 100,000, or <u>USD 100,000</u> for USD portfolios.
